On thorough discussion of the matter, the Local Committee of HQ has unanimously decided to revise the dates of our 19<sup>th</sup> Conference from 12<sup>th</sup> and 13<sup>th</sup> October 2019 to 14<sup>th</sup> and 15<sup>th</sup> December 2019.
