PARTICIPATE IN THE DEMONSTRATIONS ON 18th NOVEMBER, 2022
and

NOT TO DO CLERICAL WORK ON 19th NOVEMBER, 2022

All India Bank Employees' Association, in terms of decision arrived at in the CC meeting held at Indore, has given programs of actions culminating in a day's strike on 19th November, 2022. Taking cognizance of the Strike call given, IBA, initiated the process of dialogue in the first week of this month. In the exercise initiated by IBA, representatives of the Bank managements, did participate, with no visible forward movement in finding solutions to the problems cropped up at Bank level.

2. Government of India, Ministry of Labour, continued their efforts initiated already by IBA, and held a conciliation exercise on 10th November 2022 at Delhi, in which the Government representative and IBA have attended. As per the practice in vogue, the labour authority has remitted back to IBA to find an amicable solution to the serious problems endangering the jobs as well as the job security, disrespecting time tested IR practices, attack on leaders of the trade unions, vacation of union premises provided to the unions based on recognition accorded by the Banks etc. IBA, once again, held the exercise of conciliatory talks today at Mumbai in which representatives of AIBEA participated. There was no visible forward movement in arriving at a workable solution in various banks.

3. In Central Bank of India and Bank of Maharashtra, our affiliates are facing serious problems. Our affiliate in Central Bank of India has served the strike notice on the Bank management to observe the Strike on 19th November 2022. The substitution to check off system and also revocation of IR facility to the unions are the retaliations from the Bank, at present.

4. Keeping the developments in the various Banks and our affiliate in Central Bank of India observing the supportive strike action on 19th November, 2022, as informed earlier, vide our circular, advise our members to participate in the **Demonstrations** on **18th November, 2022** organised by the State Federations. On the Strike Day, **19th November 2022**, our members are **not to do the clerical work**, as a fraternal support to the striking workforce in our Industry.
