### **MERIT SCHOLARSHIP FOR MEMBERS' CHILDREN-2020 – RESULTS**

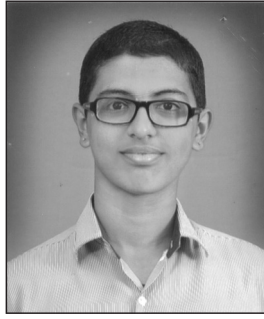

Members are aware that we have called for entries from the members to compete for the Merit Scholarship for the academic year 2020, wherein the outstanding children of the members who have secured highest percentage of marks in S.S.L.C/Equivalent examination and Pre-University/Equivalent examination are to be awarded with merit scholarship for pursuing higher education. Due to outbreak of COVID-19 pandemic, there was delay in conducting of SSLC / PUC / Equivalent examinations and announcing of results in several states. **Therefore, the last date for the receipt of the entries was fixed as 30<sup>th</sup> November, 2020.**

According to the scheme, **the first five applicants** who have secured highest percentage of marks in the order of merit in **S.S.L.C/Equivalent examination** will be declared as successful candidates and will be awarded with the merit scholarship for their higher education. In case of **PUC/Equivalent examination**, there are three categories namely, **Science, Commerce and Arts**. In the order of merit the **first four in Science category** and the **first two each in the Commerce and Arts categories** who score highest percentage of marks will be declared as successful candidates and will be entitled to merit scholarship for higher education.

This year we have received **17 applications under S.S.L.C and 14 applications in PUC under Science Category, 6 applications under Commerce Category and Nil under Arts category** respectively. The sub-committee headed by **Com. Shashikanth Raayasa, Organising Secretary**, which has been entrusted with the work, has scrutinized the applications received on the basis of merit and we are happy to declare the winners for the academic year 2020 as detailed below:

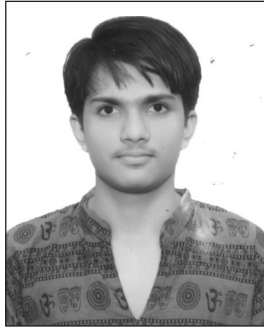
