TO PROTECT THE PUBLIC SECTOR FINANCIAL INSTITUTIONS

In terms of the communication received from Sri. Sanjay Dabi, Deputy CLC (C), Mumbai, the proceedings which was held on 22.01.2026 was attended by Com. V. Viswanathan, President, AIBOA – MSC. In continuation of the proceedings held yesterday, today's meeting was attended by Com. V. Anil Kumar, Vice Chairman, Com. D.S. Ganesan, Com. A.V. Vithal Koteswara Rao, Com. Krishna Baroorkar, Com. V. Viswanathan along with the undersigned.

2. IBA was represented by Sri. Gopal Murli Bhagat, Dy. C.E, IBA in the conciliation proceedings.
3. On behalf of our organization, we have submitted documentary evidences pertaining to the representative character of the elected representatives, detailed submission pertaining to the need to protect the public sector financial institutions, viz., IDBI, RRBs & also LIC from the proposed exercise of dis-investment besides the 6 issues raised in the strike notice.
4. IBA representative responded with the current status of the issues raised by us.
5. The entire proceedings lasted for more than 4 hours where the learned conciliation officer persuaded skillfully to defer the strike in the interest of the public at large with human considerations.

6. Since the Government representative was not present to inform the current status of the issues raised by us in the matter of dis-investment exercise and the response from the representative of the IBA was not convincing, in our considered opinion, we have expressed our inability to defer the strike.

7. **Hence we call upon the State Committees and the Affiliated Units to observe the strike on 27th January 2026 and make it a grand success.**
