A meeting of the office-bearers of CCBIFU was held at MUMBAI on 16th May, 2018 at MSBEF office. The meeting was attended by the representatives of AIBEA, AIBOA, GIEAIA and AILICEF. The meeting was presided over by Com. C.H. Venkatachalam, Chairman of CCBIFU. Com. A.V. Nachane, veteran leader of AILICEF too participated. From our organisation Com. Alok Khare and the undersigned attended the meeting.

The meeting deliberated in detail the present situation gaining ground in the matter of privatisation of Banks and Insurance Sector, FRDI bill pending before the Parliamentary committee and also the impending the wage revision in the Banking. There was also a specific mention about the much delayed and over- due wage revision in IDBI. Outsourcing of the permanent jobs is becoming the order of the day in both the Industries. There is an urgent need to prepare the members to face the challenges in the Industries coupled with the citizens at large about the negative provisions of the FRDI bill too.

ISSUES ARE: 1. Do not Privatised Banks. 2. Do not disinvest in GIC. 3. Stop FDI in Banks and Insurance Sector. 4. Withdraw FRDI bill 5. Adequate recruitments in Banks, LIC and GIC 6. Stop outsourcing and contract jobs and 7. Expedite wage revision.
