# OUR LIST OF DEMANDS

Our Managing Committee which met on the 11<sup>th</sup> and 12<sup>th</sup> of June, 2016 at Hyderabad discussed at length on several demands pertaining to the Managers/officers and it was decided to place the same before the management. Also, in several get-togethers conducted recently at different centres, members raised these demands requesting for a speedy settlement. Accordingly, we have placed a list of demands before the Management. In this connection, we have addressed a letter to the Managing Director on 25-07-2016, requesting for an early and amicable settlement in the matter. We reproduce herewith the excerpts of our letter No. KBOO/113/2016 dated 25-07-2016 for the information of our members:-

Dear Sir,

### Sub: Demands

Our Managing Committee meeting which was held on the 11th and 12th of June, 2016 deliberated in depth on several demands of the Managers/officers and it was unanimously decided to place the same before the management. Moreover, in the recently held get-togethers at many centres, our members also raised several demands pertaining to the Managers/officers. Accordingly, we place before the Management the following demands for an amicable settlement.

### 1. Fair and transparent transfer policy for the officers:

At present there is no transfer policy pertaining to the transfer of officers in our Bank. To bring credibility and uniformity to the system of transfers, we demand a comprehensive, fair and transparent transfer policy for the officers.

### 2. Increase in Business Development Expenses:

The BDE was last revised on 01-05-2006 and there is an all-round increase in the expenses relating to the business development during the last 10 years. Moreover, the present day business development activities have undergone a sea change with

the addition of several new activities/areas in tune with the demands of the present day competitive banking. Hence, we demand an increase in BDE limit as follows:

# 3. Increase in Lodging expenses:

The lodging expenses limit was last revised with effect from 01-01-2008 and during the last 8 years there has been a marked increase in the lodging expenses on account of increase in room tariff charged by the hotels. Hence we demand an increase in the lodging expenses limit as follows:

# 4. Conveyance expenses :

The conveyance allowance payable to the Branch Heads/officers was last revised on 01-04-2004 and during these 12 years due to multifarious business development activities and also in view of the increase in the distance covered between the residence and the branch/office, the conveyance expenses incurred by the Branch Managers/ officers has increased by leaps and bounds. As such, we demand an upward revision of conveyance allowance limit as follows:

5. Leased Quarters Rent: The rental ceiling for the leased quarters was last revised on 01-04-2013 and more than 3 years has elapsed from the last settlement. During these years there has been a steep increase in rents payable by our members in all centres especially in cities and urban areas. Hence we place a demand for the upward revision of rental ceiling as follows:

Hence, we demand that one more option may be given to the officers to exercise their option to choose between Scheme 'A' and 'B'.

As your goodselves will appreciate that the above said demands placed by us are just and genuine demands of the officers. Moreover, many of the peer group Banks have already revised these allowances/limits of their officers some time back. As such, we request you to invite us for a discussion on the above matter at the earliest so as to come to an amicable understanding on the issues.
