### **DEMAND SERVED FOR ENHANCEMENT OF CANTEEN ALLOWANCE AND FOREIGN TRAVEL FACILITY TO THE OFFICERS**

We have today placed a demand with the Management for the enhancement of Canteen Allowance from Rs.750/- to Rs.1500/- per month and also sought foreign travel facility to be made available to the Officers as part of LFC Scheme vide our letter No. KBOO/01/2018 dated 04-01-2018 addressed to the Managing Director. We reproduce herewith the excerpts of the same for the information of the members.

- 1. CANTEEN ALLOWANCE/SUBSIDY:** At present Canteen Allowance/Subsidy is being paid to the officers @ Rs.750/- per month with effect from 01-01-2014 in terms of the understanding arrived at between the Management and the Organisation as on the 9<sup>th</sup> December, 2013. But over a period of last 4 years there has been a steep increase in the cost of tea/coffee and snacks on account of inflation etc. This has resulted in sharp increase in the canteen expenses being spent by our members. Under the circumstances our members have represented to us seeking enhancement in the Canteen Allowance/Subsidy.

Accordingly we herewith place a demand for the enhancement of Canteen Allowance from Rs.750/- to Rs.1500/- per month to the officers.

- 2. IMPROVEMENT IN LFC BENEFIT –FACILITY FOR FOREIGN TRAVEL:** It has been the long pending demand of the officers for foreign travel facility incorporated in the LFC Scheme. Even in the recent Charter of demands placed before the IBA, Officers' unions demanded that the Foreign Travel to be allowed within the maximum distance permissible in India.

In view of the above, we request you to allow Foreign Travel in the LFC scheme for the officers as a special case.

We request you to invite us for a joint meeting to arrive at a mutual understanding on the above said issues at the earliest.
