OUTSOURCING OF REGULAR AND NORMAL BANKING JOBS TO PRIVATE AGENCIES-A FRAUD PRONE AREA –AIBEA AND AIBOA: Outsourcing of normal and regular banking jobs to private agencies is always fraught with risks as the systems and procedures that is being followed in the banks will be exposed to the public at large. Especially in the present scenario of frauds of gigantic size taking place in the banking field, it is all the more **risky to outsource regular and normal banking functions to private agencies.** AIBEA and AIBOA is of the considered opinion that besides killing jobs and job opportunities, these outsourcing of normal banking functions to private agencies will result in compromising many risk factors like reputation risk, operational risk, legal risk etc. and in this context called for the creation and heightening of awareness among the rank and file about the menace of outsourcing.

CBI AND ED TIGHTENS THE GRIP ON MEHUL CHOKSI OF GITANJALI GEMS – ATTACHES ASSETS WORTH Rs.1217 CRORES: The bank fraud of gigantic size perpetrated **by Nirav Modi and his business partner and relative Mehul Choksi of Gitanjali Gems, is becoming curious and curious day by day.** The size of the fraud has already exceeded Rs.17000/- crores with the addition of Rs.1230 crores declared by the PNB. It has been reported that CBI has interrogated the former CMD of PNB, MS. Usha Ananthasubramanian in the above fraud case pertaining to the forged Letter of Undertakings (LOU) of Nirav Modi. Mr. Kannan, ED of ICICI Bank was also questioned by the CBI regarding the Rs. 5280 crores of fraud committed by Mehul Choksi of Gitanjali Gems to 30 banks.

With a view to stem the rot, **both AIBEA and AIBOA has demanded a thorough enquiry on all aspects of the bank fraud and the loans extended to Nirav Modi and Mehul Choksi of Gitanjali Gems** and demanded that the top executives and officials responsible and connected to such fraudulent loans should be brought to book. This is a must to save the banking industry and to restore confidence of the public in the banking system.

The Finance Ministry has finally has put their act together and ordered a CBI probe on all loans over Rs. 50 crores granted to Nirav Modi, Mehul Choksi of Gitanjali Gems and others. But what we see is the usual blame game and making the innocent officers and clerks at the lower levels as scapegoats and subjecting them to transfers in the name of CVC advisory etc.
