MERIT SCHOLARSHIP FOR MEMBERS' CHILDREN - 2025 – RESULTS ANNOUNCED!

Members are aware that we had invited applications from our members for the **Merit Scholarship** for the academic year 2025, under which the outstanding children of our members securing the highest percentage of marks in the S.S.L.C/Equivalent Examination and Pre-University/ Equivalent Examination are awarded merit scholarships to pursue their higher education.

Considering the increase in membership and with a view to further encourage academic excellence and broaden the reach of our welfare initiatives, the **Managing Committee of KBOO**, in its recent meeting, reviewed and modified the Merit Scholarship Scheme by enhancing the number of scholarships under both the **SSLC and PUC** categories.

After the modification, the total number of scholarships has been increased from 13 to 20, and the total annual scholarship disbursement has been enhanced from ₹2,70,000 to ₹3,75,000. The details of the revised scheme were communicated to all members vide our Circular No. 04/2025 dated 01-08-2025.

As per the scheme, the **first ten applicants** securing the highest percentage of marks, in the order of merit, in the **S.S.L.C/Equivalent Examination** will be awarded the Merit Scholarship for pursuing higher education.

In the case of the **Pre-University/Equivalent Examination**, there are three categories — **Science**, **Commerce**, **and Arts**. In the order of merit, the **first five in the Science category**, the **first three in the Commerce category**, and the **first two in the Arts category** securing the highest percentage of marks will be declared successful candidates and will be awarded the Merit Scholarship for higher education.

For the current year, we have received 20 applications under the S.S.L.C category, 12 applications under the PUC Science category, 1 application under the PUC Commerce category, and no applications under the PUC Arts category.

The Sub-Committee, headed by **Com. Shashikanth Raayasa**, **Organising Secretary**, which was entrusted with the responsibility of scrutinising the applications, has evaluated them on the basis of merit. We are delighted to announce the results of the Merit Scholarship Awards to the children of our members for the academic year 2025, as detailed below:

We congratulate all the winning candidates whose outstanding performance has earned them the Merit Scholarship, and extend our heartfelt appreciation to all the participants for their hard work and enthusiasm. We wish them the very best in their future studies. We are also confident that this recognition from the Organisation will further inspire and motivate them to excel in their academic pursuits and achieve greater success in the years ahead.

The winners are required to submit **confirmation certificates of admission** for their higher studies. The scholarship amount for **S.S.L.C./Equivalent Examination** winners will be ₹10,000/**each**, and for **P.U.C./Equivalent Examination** winners, the scholarship amount will be ₹15,000/**per candidate** opting for a graduation course and ₹40,000/- **per candidate** opting for a technical course.

Upon scrutiny of the confirmation certificates received from the respective members, the eligible amount of the Merit Scholarship will be disbursed to the winners. The total outlay under the Merit Scholarship Scheme amounts to ₹3,75,000/- (Rupees Three Lakh Seventy Five Thousand only).

Further, we are disheartened to note that despite our sincere efforts to encourage academic excellence, expand the scope of our welfare initiatives, and increase the number of scholarships under the *Pre-University/Equivalent Examination – Commerce Category* and *Pre-University/Equivalent Examination – Arts Category*, we received an insufficient number of applications in the Commerce category and none in the Arts category.

We have observed that many children of our members are pursuing Commerce and Arts streams at the Pre-University (PU) or equivalent level. **Unfortunately, many eligible students miss out on receiving the Merit Scholarship due to a lack of awareness among members, resulting in the loss of well-deserved recognition and encouragement for their academic achievements.**

We sincerely urge all members to ensure that scholarship applications are submitted on behalf of their meritorious children in the coming years. By doing so, you provide them with an opportunity to have their talent acknowledged and their hard work rewarded, thereby motivating them to strive for even greater academic success.
