MERIT SCHOLARSHIP FOR MEMBER'S CHILDREN - ACADEMIC YEAR 2023

* * * * *

Members are aware that our Organisation had introduced the Merit Scholarship Scheme for the member's children from the academic year 2007. As per the said Scheme, each year Merit Scholarship is being awarded to the outstanding children of our members considering the marks secured by them in **SSLC / Equivalent examination and Pre-University Course / Equivalent examination**. Accordingly, in the case of SSLC / Equivalent examination **in the order of merit the first five** who score highest marks amongst our members' children will be declared as successful candidates and will be entitled for the merit scholarship for pursuing their higher education. In the case of PUC / Equivalent examinations, there will be **three categories namely, Science, Commerce and Arts**. **In the order of merit, the first four in Science category and the first two each in Commerce and Arts categories** respectively who score the highest mark will be declared as successful candidates and will be entitled for merit scholarship for pursuing their higher studies.

We are pleased to call for entries for the academic year 2023 from our members, whose children had appeared for the above examinations, detailing the **full particulars of their son / daughter, total marks obtained, percentage of marks along with a copy of the marks card duly attested by their respective School / College and their passport size photo (color)** to us so as to compete for this merit scholarship.

Disbursement of Scholarship amount and conditions thereof as per the Scheme:

The scholarship amount to be awarded to each member's children for the purpose of higher education will be **Rs.10000/- in case of SSLC / Equivalent examination** and in the case of **PUC / Equivalent examination**, the scholarship amount to be given to the children for the purpose of higher studies will be **Rs.15,000/-** in case member's children opting for **graduation course such as B.Sc., B.Com., B.A. etc.** The scholarship amount shall be **Rs.40,000/-** in case the members' children opt for **technical courses such as BE/MBBS/BDS etc.**

Members may be pleased to know that the total amount to be awarded to our member's children under the Merit Scholarship Scheme works out to **Rs.2,70,000/- per year.**

The winners of the scholarship of our member's children on the basis of merit will be published through our circular after the scrutiny of the marks card submitted to us by all the eligible members. On getting the confirmation from the concerned members that the recipient of scholarship is admitted to the various courses mentioned above, the scholarship amount will be sent through a demand draft to the concerned.

Now that the SSLC / Equivalent examination and Pre-University Course / Equivalent examination results are already published in Karnataka and in other states, our members concerned should take necessary steps in this direction and send their applications at the earliest to us so as to compete for this Merit Scholarship of the Organisation. Upon receipt of the applications, we will send the acknowledgement to the concerned members. The members are advised to contact us if they do not receive the acknowledgement for their applications within the reasonable time.
