- ❖ DEMAND FOR REVISION OF FITMENT FOR OFFICERS ON SCALE WISE PROMOTION

Members are aware that we have called for entries from the members to compete for the Merit Scholarship for the academic year 2015, wherein the outstanding children of the members who have secured highest percentage of marks in S.S.L.C/Equivalent examination and Pre-University/Equivalent examination are to be awarded with merit scholarship for pursuing higher education. The last date for the receipt of the entries was fixed as 5th August 2015 vide our Circular No. 10/2015 dated 21.07.2015. According to the scheme, the first five applicants who have secured highest percentage of marks in the order of merit in S.S.L.C/Equivalent examination will be declared as successful candidates and will be awarded with the merit scholarship for their higher education. In case of PUC/Equivalent examination, there are three categories namely, science, arts and commerce. In the order of merit the first four in science category and the first two each in the arts and commerce categories who score highest percentage of marks will be declared as successful candidates and will be entitled to merit scholarship for higher education.

This year we have received **15 applications under S.S.L.C** and **9 applications in PUC under science category, nil under arts** and **1 under commerce** categories respectively. The sub-committee headed by Com.Jagannathan M., Vice-President, which has been entrusted with the work, has scrutinized the applications received on the basis of merit and we are happy to declare the winners for the academic year 2015 as detailed below:

The winners are required to submit the confirmation certificates for their admission for higher studies. The scholarship amount in case of S.S.L.C./Equivalent examination will be Rs. 5,000/- each and in respect of PUC/Equivalent examination, the eligible amount of scholarship will be Rs.7,500/- per candidate opting for graduation course and Rs.20,000/- per candidate opting for technical course. On scrutiny of the confirmation certificate received from the concerned members, the eligible amount of merit scholarship will be sent to the winners. The maximum amount involved under the merit scholarship scheme is Rs.1,12,500/- (Rs. One lakh twelve thousand five hundred only). We hope that this competition will further enthuse more and more children of our members and drive them to excel in their studies in the days to come.

REVISION OF FITMENT FOR OFFICERS ON SCALEWISE PROMOTION: IBA has revised the scale wise fitment formula for officers on promotion w.e.f. 01-11-2012, consequent upon the revision of pay scales of Officers as per the Joint Note dated 25-05-2015. Accordingly we have placed a demand with the Management to take early steps to revise the fitment of our members promoted from one scale to a higher scale with effect from 01-11-2012. We reproduce hereunder the extract of our letter No. KBOO/96/2015 dated 24-08-2015 addressed to the Management for the information of our members.

Dear Sir.

Reg: Demand for revision of fitment of Pay scales of our members on promotion from one scale to a higher scale - Joint Note dated 25-05-2015.

We note that IBA has revised the fitment formula of pay scales for officers on promotion from one scale to a higher scale w.e.f. 01-11-2012, consequent upon the revision of pay scales as per the Joint Note dated 25-05-2015 and advised the member Banks to adopt the same w.e.f. 01-11-2012 vide their letter No. CIR/HR&IR/582A/2015-16/1196 dated 07-08-2015.

Accordingly, we place a demand for revision of fitment of pay scales to our members on promotion from one scale to a higher scale w.e.f. 01-11-2012 and also payment of arrears, under intimation to us.
